TERMS & CONDITIONS AGREEMENT

The undersigned ("Purchaser") agrees that all purchases from **BPGraphics, Inc.** ("Seller") are subject to the following terms and conditions:

- 1) Purchaser acknowledges that invoices are not payable in installments, but are payable in full within 30 days from invoice date.
- 2) All amounts due seller are payable in accordance with the payment terms granted by Seller's credit department from which the goods and services are delivered. If any amount due Seller is not paid in accordance with such payment terms, a delinquency charge may be added to the sum due.
- 3) Purchaser shall pay Seller a service charge in an amount equal to the greater of \$30.00 or 5% of the check balance for all checks returned by Purchaser's bank; provided, however that such service charge shall not be due and payable in the event such payment would result in the violation of the usury laws of the applicable jurisdiction.
- 4) In the event the account is turned over to an attorney or other agency for collection, or suit is brought on same, or the same is collected through any judicial proceeding whatsoever, Purchaser shall pay all attorneys' fees and court costs incurred by Seller.
- 5) Purchaser warrants to Seller that all financial information furnished for the purpose of obtaining credit is true, correct, and complete in all material respects. Purchaser authorizes Seller to inquire into obtaining from any bank, lending institution, or credit reference, whether listed on this Credit Application or not, any and all information relating to applicant's credit worthiness or financial condition.
- 6) Purchaser agrees to waive its right, if suit is brought, to being brought in the county of its residence and agrees that venue will be at the option of the Seller.
- 7) Should credit availability be granted by the Seller, all decisions with respect to the extensions or continuation shall be in the sole discretion of the Seller. The Seller may terminate any credit availability within its sole discretion.
- 8) Purchaser further agrees that it will immediately, but no later than five days after any change of ownership or change of form of Purchaser has been concluded, notify Seller by certified mail, return receipt requested. Failure of Purchaser to deliver said notice to Seller will result in the Purchaser's remaining liable to Seller for all credit purchases of the new owner or the new business form utilized.
